The aim of the BMS is to involve all staff in the benefits of any decisions and facilitate the ability to continually improve environmental performance. It is LPL Construction Services objective to operate with, and to maintain good relations with all regulatory bodies and comply with all legal requirements.

- \\ Reduce waste arising from surplus and damaged materials by accurate measuring and greater care in storage.
- \\ Reduction in energy use by pre-planning and improved utilisation of resources.
- \\ Pollution prevention by avoiding the use of environmentally hazardous substances by design.
- \\ Improving efficiency by planning work methodically and maintaining worn equipment.
- \\ Reduction in waste materials including recycling concrete, aggregates, timber glass, metal, paper and cardboard
- \\ Prioritise biodiversity eco systems when planning our projects, ensuring our works provide a positive contribution to the environment. Where we impact these important ecosystems, we commit to implement solutions that will enhance the environment during and at completion of our projects. The protection of flora and fauna along with their associated habitats remain a key focus for our teams.
- \\ Avoiding contamination of watercourse by ensuring appropriate arrangements, COSHH assessments, permits and discharge notices are in place where appropriate.
- \\ Reduce harmful emissions by continuous investment in new vehicles and machinery whilst also reducing engine revolutions or switching off whilst not in use.
- \\ Research and trial new technologies and products as they are developed.

The Board of Directors will provide support for investment in carbon data capture and reduction initiatives. This policy is communicated to all employees, suppliers and subcontractors and is made available to the public.
