Through this initiative, we ensure our suppliers are aligned with our requirements which not only supports the education of the wider sector but facilitates long and mutually beneficial relationships.

As of 2024, our suppliers completed 24 training courses. We goal to increase this through 2025 and beyond. In addition to this training, we will continue to develop and adapt our own tools for enhancing responsible sourcing, supporting innovation and future developments within the industry.
